- object to the processing of personal data, in case of processing data based on legitimate interest,
- object to automatic profiling,
- withdraw at any time the consent given for the processing of personal data (withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal).

If you believe that the processing of personal data violates the provisions of the GDPR, you have the right to lodge a complaint with the supervisory authority responsible for personal data protection, i.e., the President of the Office for Personal Data Protection.

#### 4. Decisions made in an automated manner
