

Regulations and General Information Regarding the Event

"BBB Challenge Episode 2"

1. The organizer of the event known as "BBB Challenge Episode 2" is a private individual who, in cooperation with a group of players associated under the name "BBB" (Black Bordered Boomers) - through their activities strives to introduce players to the intricacies of playing MTG and enable physical gameplay by organizing live meetings.
2. The Event Organizer reserves the right to change these regulations at any time.
3. The Organizer reserves the right to refuse participation to a player without giving a reason, in which case the entry fee will be fully refunded to the account from which the payment was made.
4. Registration for participation in the "BBB Challenge Episode 2" event is equivalent to accepting the regulations and familiarizing oneself with them.
5. Participation in the event is tantamount to consent to the use of one's image for promotional purposes and the sharing of the submitted decklist.
6. The event will take place at the premises of the Polish-Japanese Academy of Information Technology, at 86 Koszykowa Street in Warsaw, from September 19 to 21, 2025.
7. Registration for individual tournaments (Old School, Premodern, Legacy) in the event, accepted through completing the application, begins on June 25, 2025, and will last until September 18, 2025. Entry fee costs are: 140 PLN - Legacy, 110 PLN - Premodern, 30 PLN - Old School.
8. The entry fee should be paid from the account of the person registering for the tournament. On the day of the tournament, the organizer reserves the right to verify the person's identity to confirm payment. Any discrepancies disqualify the player from further participation in the tournament, and the entry fee - as an organizational cost - will not be refunded.
9. Minors should make the transfer from their legal guardian's account, and in the transfer title, provide the name and surname of both the participant and the guardian. On the tournament day, the player should appear with their legal guardian. Point 8 of the regulations applies to both the guardian and the participant.
10. In case of wishing to withdraw from playing, it is possible to transfer the entry fee to someone else. In such a case, it is necessary to contact the Organizer. The permissible deadline for reporting any substitutions is September 10, 2025.
11. In case of intention not to attend the tournament, the Organizer would be grateful for advance information about the absence.
12. The Organizer does not provide parking or accommodation at the tournament venue. Accommodation and parking must be arranged independently.

13. The Organizer does not provide access to catering during the event, unless the air temperature on the tournament day exceeds 30 degrees Celsius. In that case, each player will receive a proverbial bottle of water from the Organizer.
14. On the premises of the facility where the "BBB Challenge Episode 2" tournament will take place, there is an absolute ban on smoking cigarettes, tobacco products, e-cigarettes, or other smoke-producing substances.
15. On the premises of the facility where the tournament will take place, there is a general ban on alcohol consumption.
16. The Organizer reserves the right to refuse entry to the tournament to intoxicated persons or those who may create a nervous atmosphere among other tournament participants.
17. The Tournament Organizer makes a special request to observe the rules of personal culture during the games. Any information that reaches the judges or Tournament Organizer regarding someone insulting, threatening, or calling names will be considered among the people concerned by the matter.
18. The Organizer appeals to players with a special request to observe fair play principles during the tournament.
19. The Organizer and persons helping to organize the tournament are not responsible for items left in the hall by other players.
20. The tournament will be held under REL Competitive rules, with the number of rounds depending on the number of players.
21. The permissible number of proxies used in players' decks will be 100% for Old School format, 30% rounded down for Legacy format, 0% for Premodern format.
22. The Organizer makes a special request to players printing proxies that they be legible, colorful, and printed in the original version of the card. Printed proxies that do not meet the stated requirements will not be accepted.
23. Decklists for each tournament should be printed in a legible manner and submitted on the tournament day. Proxy cards should be appropriately marked so that it can be unambiguously determined which card it is.
