Regulations and General Information Regarding the Event "BBB Challenge Episode 1"

- 1. The organizer of the event known as "BBB Challenge Episode 1" is a group of players associated under the name "BBB" (Black Bordered Boomers), which aims to introduce players to the intricacies of MTG and enable physical gameplay by organizing live meetings.
- 2. The event organizer reserves the right to change the following regulations at any time.
- 3. The organizer reserves the right to refuse participation to a player without providing a reason. In such a case, the entry fee will be fully refunded to the account from which the payment was made.
- 4. Registering for the "BBB Challenge Episode 1" event is equivalent to accepting and familiarizing oneself with the regulations.
- 5. Participation in the event organized by the "BBB" group implies consent to the use of one's image for promotional purposes and the sharing of the submitted decklist.
- 6. The event will take place at the headquarters of the Polish-Japanese Academy of Information Technology, at Koszykowa 86 in Warsaw, from September 13 to 15, 2024.
- 7. Registrations for each tournament (Old School, Legacy, Premodern) in the event are accepted via email: blackborderedboomers@gmail.com and begin on June 28, 2024 and will continue until September 3, 2024. The entry fee is 130 PLN for Legacy, 80 PLN for Premodern, and 30 PLN for Old School.
- 8. The entry fee should be paid from the account of the person registering for the tournament. On the day of the tournament, the organizer reserves the right to verify the identity of the person to confirm payment. Any discrepancies disqualify the player from further participation in the tournament, and the entry fee as an organizational cost will not be refunded.
- 9. Minors should make the transfer from their legal guardian's account, and in the transfer title, provide the name and surname of both the participant and the guardian. On the tournament day, the player should appear with their legal guardian. Point 8 of the regulations applies to both the guardian and the participant.
- 10. In case of a desire to withdraw from the game, it is possible to transfer the entry fee to someone else. In such a case, it is necessary to contact the Organizer. The acceptable deadline for reporting any changes is September 1, 2024.
- 11. In case of intention not to appear at the tournament, the Organizer would appreciate prior information about the absence.
- 12. The organizer does not provide parking or accommodation at the tournament venue. Accommodation and parking should be arranged independently.
- 13. The organizer does not provide access to catering during the event, unless the air temperature on the day of the tournament is above 30 degrees Celsius. In that case, each player will receive a bottle of water from the Organizer.
- 14. On the premises where the "BBB Challenge Episode 1" tournament will take place, there is an absolute ban on smoking cigarettes, tobacco products, e-cigarettes, or other smoke-producing substances.

- 15. There is a general ban on alcohol consumption on the premises where the tournament will take place.
- 16. The organizer reserves the right to refuse entry to the tournament to intoxicated persons or those who may create a nervous atmosphere among other tournament participants.
- 17. The tournament organizer makes a special request to observe the rules of personal culture during the games. Any information that reaches the judges or the tournament Organizer regarding someone insulting, threatening, or abusing another person will be considered on the spot among the persons concerned.
- 18. The organizer asks the players to especially observe the rules of fair play during the tournament.
- 19. The organizer and persons helping to organize the tournament are not responsible for items left in the room by other players.
- 20. The tournament will be held on the basis of REL Competitive, with the number of rounds depending on the number of players.
- 21. The allowable number of proxies used in players' decks will be 100% for the Old School format, 30% rounded down for the Legacy format, and 0% for the Premodern format.
- 22. The organizer makes a special request to players printing proxies that they be legible, in color, and printed in the original version of the card. Printed proxies that do not meet these requirements will not be accepted.
- 23. Decklists for each tournament should be sent to blackborderedboomers@gmail.com by September 5, 2024, or printed legibly and submitted on the day of the tournament. Proxy cards should be appropriately marked so that it can be clearly determined which card it is.
